Subject:- Appointment of Chief Information Commissioner in State Information Commission.

1. The Government of Rajasthan under powers conferred by the Right to Information Act 2005 (to be referred hereinafter as the Act) has constituted the Rajasthan State Information Commission to exercise such powers and to perform such functions as conferred/assigned to it under the Act (chapter V of the Act). It is located in Jaipur.
2. It is proposed to appoint a new Chief Information Commissioner in the Rajasthan State Information Commission in view of the vacancy arisen due to superannuation of its previous incumbent. The Act provides that the Chief Information Commissioner shall be a person of eminence in public life with wide Knowledge and experience in law, science and technology, social service, management, journalism, mass media or administration and governance.
3. The State Chief Information Commissioner shall not be a member of Parliament or Member of any State Legislature or Union Territory as the case may be or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession.
4. Chief Information Commissioner shall hold office for a term of five years, from the date on which he enters upon his office or till he attains the age of 65 years, whichever is earlier, and shall not be eligible for reappointment as State Chief Information Commissioner. The salary and allowances payable to State Chief Information Commissioner shall be as specified in sub-section (5) (a) of section 16 of the Act.
5. A state information commissioner may also apply for the post of chief information commissioner after vacating the office but the term of appointment of such appointed chief information commissioner shall not in aggregate exceed 5 years including both the terms.
6. The conditions of appointment provided in the Act of 2005 shall be final.
7. Persons fulfilling the criteria for appointment as Chief Information Commissioner and interested for appointment to the post may send their particulars by post or by hand to the Additional Chief Secretary, Administrative Reforms & Coordination Department, Government of Rajasthan, Room No. 8202, S.S.O.
